## **ADHOC**

**Centennial:** Jeffrey Davenport and Avery Millisock reported that the last Centennial Committee Meeting had 9 attendees and was held on October 7. Topics discussed included debates over blood drives and leave no trace service projects.

Chris Conville designed a new logo for the red Nalgenes with gray caps that were ordered in August. That same logo can be used on bumper stickers. Brant Portner recommended a new pocketknife design for the Centennial Committee. There are two price options. There is a cheaper one that would be sold at about \$15 dollars per unit and a collector's knife that would be sold at \$35-\$40 per unit. That discussion will be finalized at the next meeting on November 4th.

The Zoom link is embedded in the lodge calendar. Jeff invited everyone to attend. The original centennial banner will be brushed up before then as will. The participation award will also be discussed at that meeting.

**Elangomat:** Elangomat Chairman Jacob Keller was not present and had nothing new to report.

## **Old Business**

**LLD:** Avery was unable to contact all chairmen about the LLD. He will do so by the next meeting.

## **New Business**

Adapt, Collaborate, and Thrive (ACT): Avery will be working sending an email out to all lodge members today. Glenn Piper noted that everyone should get involved in the three key functions of a lodge: Elections, Inductions, and Activiations. He wants everyone possible to attend that conference. Not only is what the section is doing, but it is what the lodge is doing. The invitation goes beyond the LEC. Up to three non-LEC members can attend.

**Momentum Spark:** Momentum Spark is a national virtual induction process on November 6-7. It will be free. For current and new members inducted, there will be leadership training. Paying a \$15 fee grants access to a patch and a copy of all of the information shared. We need to work to reach out to candidates to get them to register. Registrants will still be doing service, a night alone, and ceremonies. The lodge will need to coordinate these things. National only provides training and a ceremony. Avery will be in contact with Jaydon to see if this is feasible for the lodge to do.

**Officer Training:** A zoom is likely the best option for officer training. The officers will stay after the meeting to decide on a day.

**Project 2021:** This is a tentative name for a project that will involve reworking lodge functions. These need to be finished by 2021. Administration will work on raising lodge fees to make them sustainable with national's requirements. The lodge participation will be reworked to encourage people to participate. Activities will work to increase

activation rates and service hours. There could be specific activation events or service days. Inductions will implement the new inductions portal and ensure the success of the extended elangomat program. Avery will talk to Jaydon since he was not present.

## **Advisor Remarks**

**Lodge Adviser:** Lodge Advisor Glenn Piper remarked that you never know who you may run into. Talk to people. You never know who they are connected to, and could help you down the road. We are not working as quickly as we need to to accomplish lodge goals. We need to start working outside of the LEC meetings. There should be committee meetings with advisors before the next LEC. He reminded us of the work calendar. He invited all present to look at what they should be doing right now until december. He asked us to evaluate ourselves on how we have been working.

**Staff Advisor:** Staff Advisor David Morgan noted that we have a lot of work to do. We need to be working together. Next year is a big year for the Lodge. We have all taken on our positions because we wanted to help others. It seems like a lot, and it is, but it is worth it. Scouting will change your life, so take advantage of all opportunities that you have. Some of the training prices have been slashed from \$500 to \$15-30. Camp needs help with service and summer camp staff. Camp is looking for NYLT trained and OA members, so consider joining staff. It is a wonderful opportunity..
