CROSSING INTERNATIONAL BOUNDRIES By Steve Dibler

[Teresa Myers, a Brotherhood member of Kittatinny Lodge V, had the opportunity to spend the past summer in Scotland as a member of International Camp Staff. Wolf's Tale was lucky to get an interview with her before she returned to Brigham Young University (BYU) in Utah for the fall term. The article that follows is based upon that interview.]

Teresa Myers, a resident of Fleetwood and a committee member in Troop 140, embarked upon a journey of international proportions this past summer. She seized the opportunity of a lifetime by becoming involved in the BSA's European Camp Staff program that she learned of at a BYU job fair. After filling out numerous applications, Teresa was overjoyed to learn that she was accepted to become a member of the summer staff at the Auchengillan Outdoor Centre, located in the southwestern corner of Scotland near Glasgow.

Teresa left the United States on June 16, not to return to America for two months. After a nine hour journey, Teresa arrived wearily in Scotland not knowing what to expect. She quickly learned that she would be one of five permanent staff members for the summer. Teresa's job responsibilities included running various activities such as archery, crate climbing,

ATV's (all terrain vehicles), and grass sledges. In addition to running these programs, Teresa worked at the camp shop (the equivalent of our trading post). Furthermore, because the camp had no permanent ranger, Teresa had to help with camp maintenance, including cleaning bathrooms, mowing grass, picking up litter, and repairing equipment.

Teresa found Auchengillan to be much different from Hawk Mountain Scout Reservation. For example, Auchengillan was much smaller than HMSR and did not have well established campsites. Instead, tents could be set up on a few open fields. Also, the camp had no dining hall like our camp. Troops were responsible to provide and cook their own meals. In addition, camp did not provide many activities such as merit badges for the campers. The troop's leadership was responsible for providing campfires, games, and other entertainment for their units.

Teresa was also lucky to be able to experience an international jamboree at Auchengillan that included both male and female scouts from all over the world. She made many friends among the over 1,000 people that attended the jamboree. She also enjoyed touring much of the Scottish countryside with her new friends and learning about Europe.

OA TROOP REPRESENTATIVE

The Order of the Arrow and the Boy Scouts of America has created a new leadership position in the Troop and the Order of the Arrow called the OA Troop Representative. (This is also a position in Varsity Scouting units) The OA Troop Representative is a leadership position that meets the Boy Scout requirements for advancement purposes up to and including Eagle Scout.

This position allows the unit to be informed and coordinate schedules, of the OA and the unit. The job description of the Troop Representative is: An Order of the Arrow Troop Representative is a youth liaison serving between the local OA lodge or chapter and his troop. In his troop, he serves as a communication and programmatic link to the Arrowman and adult leaders and Scouts who are not presently members of the Order. He does this in a fashion that strengthens the mission of the lodge and purpose of the Order. By setting a good example, he enhances the image of the Order as a service arm of his troop.

Some of his duties may include:

- Communications link between lodge or chapter and troop
- Encourages year-round and resident camping the troop
- Encourages older Scout participation in High Adventure program
- Encourages Scouts to participate in community service projects
- Teaches leadership skills in the troop
- Encourages Arrowmen in the troop to assume leadership positions.
- Encourages Arrowmen in the troop to be active participants in the lodge and/or chapter activities and seal their membership in the OA by becoming Brotherhood members.
- Wears the Scout uniform correctly and enthusiastically
- Live by the Scout Oath and Law an OA Obligation

To be an OA Troop Representative the Scout must be under 18 years of age, appointed by the Senior Patrol Leader with Scoutmaster approval, and is a registered member of the Arrow member.

The OA Troop Representative reports to an Assistant Senior Patrol Leader. As with all positions in the Order, the OA Troop representative should have an adult as his Adviser. This adult should be over the age of 21, be a dues-paid member of the Order of the Arrow and be appointed by the Scoutmaster.

The troop, the Order of the Arrow, Scouts, Order of the Arrow members, and our local communities should benefit from this new leadership position and the results of the leadership given by the OA Troop Representative.



EXECUTIVE NOTES

TRIVIAL PURSUITS

Six years after the formation of the Order at Treasure Island (1921), lodges urged the formation of a national organization. The group, then known as the "Grand Lodge of WWW", met at the Philadelphia Council office and Treasure Island to vote on a constitution, committees and three national officers. Elected were E. Urner Goodman - Grand Chief, E. R. Carrick - Grand Secretary, and Arthur A. Schuck - Grand Treasurer. Mr. Schuck was then the Scout Executive in Reading. On Oct 6-7, 1922, the Grand Lodge of WWW convened it's second annual meeting in Reading, with Scout Executive Schuck acting as host. Mr. Schuck later went on to become the Chief Scout Executive of the Boy Scouts of America in the late 1940's.

CONFERENCE / CONCLAVE

Two major opportunities are coming up this year for any member to participate in OA activities beyond our lodge. On June 9-11, Goose Pond Scout Reservation and Lowwapanew Lodge 191 will serve as host to the Section 4-A Conclave. The theme this year is **"Many Arrows ... One Path"**. Conclaves are held each year and moves from lodge to lodge on a rotation schedule.

NOAC (National Order of the Arrow Conference) 2000 is scheduled to take place from Saturday, July 29 through August 4 on the campus of the University of Tennessee in Knoxville. Approximately 6,800 members are expected to attend or staff the Conference. NOAC is held every two years. Along the way, Kittatinny will be a visit and tour of Morgan/McClure Motorsports (NASCAR #4) and the Smokey Mountain Knife Works. Cost for NOAC is \$480.00 and includes 2 NOAC flaps, 1 NOAC chenille, 2 contingent T-shirts, transportation, accommodations at UT, all meals, and OA Memories to last a lifetime.
