

Ordeal/Elangomat and Troop/Team Rep Bylaw Changes

Amending the Bylaws

Article XII- Amending the Bylaws

1. Any and all bylaw changes must be voted on and approved at a general membership meeting.
2. The LEC must vote on and approve bylaw amendments/changes prior to the general membership voting on the proposed bylaw amendment/change.
3. Bylaw changes shall be published to the general lodge membership 30 days in advance to the scheduled vote.

Current Bylaws

Article VI – Committees

1. The LEC shall be comprised of the following committees: Activities, Brotherhood, Ceremonies, Camp Promotions & Elections, Communications, Conference/Conclave, Elangomat, Health & Safety, Historian, Kitchen, Kittatinny Inc, Membership, Ordeal, Service, Troop/Team Rep, and Vigil.
2. The Lodge Chief shall appoint all youth committee chairman and create and appoint a chairman of ad-hoc committees as needed in consultation with the Lodge Adviser. The Lodge Adviser shall appoint all adult committee advisers and appoint advisers to ad-hoc committees as needed in consultation with the Lodge staff Adviser.
3. The Vice Chief of Administration will directly work with and oversee the following committees: Kitchen, Membership, Troop/Team Rep, Vigil
4. The Vice Chief of Activities will directly work with and oversee the following committees: Activities, Conference/Conclave, Health & Safety, Historian, Kittatinny Inc., Service
5. The Vice Chief of Inductions will directly work with and oversee the following committees: Camp Promotions & Elections, Ceremonies, Elangomat, Ordeal, Brotherhood
6. The Lodge Secretary will directly work with and oversee the Communications Committee.

Proposed Change

Article VI – Committees

1. The LEC shall be comprised of the following committees: Activities, Brotherhood, Ceremonies, Camp Promotions & Elections, Communications, Conference/Conclave, Elangomat, Health & Safety, Historian, Kitchen, Kittatinny Inc, Membership, Ordeal, Service, OA Unit Rep, and Vigil.
2. The Lodge Chief shall appoint all youth committee chairman and create and appoint a chairman of ad-hoc committees as needed in consultation with the Lodge Adviser. The Lodge Adviser shall appoint all adult committee advisers and appoint advisers to ad-hoc committees as needed in consultation with the Lodge staff Adviser.
3. The Vice Chief of Administration will directly work with and oversee the following committees: Kitchen, Membership, OA Unit Rep, Vigil
4. The Vice Chief of Activities will directly work with and oversee the following committees: Activities, Conference/Conclave, Health & Safety, Historian, Kittatinny Inc., Service
5. The Vice Chief of Inductions will directly work with and oversee the following committees: Camp Promotions & Elections, Ceremonies, Elangomat, Ordeal, Brotherhood
6. The Lodge Secretary will directly work with and oversee the Communications Committee.

Note

- The Elangomat function will still be in-use and will become a sub-function/committee within the Ordeal committee.
